1. INSTRUCTIONS TO PROPOSERS

- 1.1 It is the Proposer's responsibility to deliver their offer by the date and time indicated in this Request For Proposal (RFP). The date and time of receipt will be stamped on the offer by the Purchasing Services Office and held in a secure place. Offers received later than the due date and time shall not be considered. Offers submitted by fax or email shall not be considered. Proposers should never leave a offer with any NMIMT office or NMIMT individual for delivery to the Purchasing Services Office.
- 1.2 This RFP contains specific requests for information. However, in responding, Proposers are encouraged to include in their offers any additional information they believe relevant and valuable. Sales and general promotional material should <u>not</u> be included, specific product literature may be included. The offer must be specific and must be responsive to the criteria set forth in this request. There is no page limit, but please be concise.
- Clarification of instructions, terms and conditions, insurance, and preparation or submission of offers shall be made only by the Purchasing Services Office. No other source within NMIMT is authorized to explain, interpret, or give information concerning this RFP document. Further, no contact between the proposers and the end-users of the goods or services is permitted until an offer is selected and a contract signed. Questions must be submitted in writing and should be restricted to clarification of the RFP. Proposers should reference their questions to specific RFP sections, paragraphs and page numbers. Questions may be faxed to 575-835-5887 or emailed to purchasing@nmt.edu. All questions must be submitted no later than 5:00 P.M. seven (7) calendar days before the proposal is due. Questions and their answers will be incorporated into an addendum which will be posted on the Purchasing website at http://www.nmt.edu/purchasing-services. Receipt of addenda must be noted on the Proposer's offer confirming the receipt of any and all amendments.
- 1.4 This RFP implies no obligation on the part of NMIMT, nor does NMIMT's silence imply any acceptance or rejection of any offer. NMIMT reserves the right to accept or reject any or all offers or any part thereof, and to waive any technicalities or informalities in the offer if in the best interests of NMIMT. Incomplete offers may result in dismissal of all or part of the response.
- 1.5 The offer should be delivered to the Purchasing Services Office at the address shown on page 1. A total of one (1) <u>original and one (1) thumb drive</u> are required. <u>Please ensure the signature is original by using a colored ink pen</u>. The completed offer must be in a sealed envelope or box marked with "Request for Proposal" and corresponding RFP number. Note: the Purchasing Services Office is closed at lunch M-F from <u>noon until 1:00 p.m.</u> if hand delivering, please time your arrival accordingly.
- Each offer must give the complete mailing address of the Proposer and must be signed by the Proposer with the Proposer's legal authorized signature on the forms included in this RFP, electronic signatures are not acceptable. An offer by partnerships must be signed by one of the members of the partnership or by an authorized representative. Offers by corporations must be signed and sealed in the name of the corporation followed by the signature and title of the president, secretary or other person authorized to bind the corporation in the matter. The names of all signers should be typed or printed below the signature. Unsigned offers will be considered non-responsive and returned to the Proposer.
- 1.7 Offers will not be opened publicly but shall be opened in the presence of the Chief Procurement Officer and one or more NMIMT representatives.
- 1.8 Offers will be evaluated on their ability to satisfy the requirements stated herein at the best obtainable price. The precise method by which the Proposer shall be evaluated is detailed further in this document.
- 1.9 If a Proposer has assisted with the development of the proposal or has provided specifications, that Proposer MAY NOT submit an offer.
- 1.10 Each offer must be typed and legible. Failure to include all information requested in the RFP documents may render the Proposer's offer non-responsive and the offer may be returned to the Proposer. All information must be entered in ink or typed and corrections must be initialed.
- 1.11 No employee of NMIMT shall have any direct financial interest with any Proposer's company. Any violation of this provision will render the offer void unless it is approved by the Board of Regents after full disclosure by the employee.
- 1.12 Proposer's response must be specific and in such form that the evaluation committee may readily compare the response to the appropriate criteria. If invited for an interview or product demonstration regarding this proposal, failure to respond to an invitation to make a presentation to the committee may result in an offer not being considered.

- Proposer's offer must be bound and indexed and must use, where required, the forms provided in the RFP. Proposers should organize each copy of their offer as follows, with a tab / section for each alpha designation and its title, in order to simplify evaluation. If the required format is not followed, the offer may be eliminated from consideration.
- 1.14 The Chief Procurement Officer will make every effort to adhere to the following schedule however the schedule is subject to change.

2. MODIFICATION AND WITHDRAWAL OF OFFER

- 2.1 Any offer may be modified prior to the established due date in accordance with the requirements of the New Mexico Procurement Code 13-1-1 et seq. NMSA 1984 Supp. A late modification of an otherwise successful offer that makes its terms more favorable to NMIMT will be considered at any time it is received.
- 2.2 If not withdrawn before the proposal opening date and except as otherwise provided in the Procurement Code, no Proposer may withdraw its offer within ninety (90) days after the actual date of the opening. Prior to award, offers may be withdrawn anytime by written notice or in person by Proposer's authorized representative.
- 2.2 No Proposer shall be deemed responsible if it has been debarred by NMIMT, if in the preceding twelve months it has failed to perform any contract, or if Proposer's bonding company has been required to complete the work of a contract for Proposer.

3. RFP TERMINATION

3.1 This RFP in no manner obligates NMIMT to the eventual purchase of any services or goods described, implied or which may be offered, until confirmed by a written contract. Progress towards this end is solely at the discretion of NMIMT and may be terminated without penalty or obligation at any time prior to the signing of a contract. NMIMT reserves the right to cancel this RFP at any time, for any reason, and to reject any or all proposals.

4. EVALUATION CRITERIA

4.1 Offers shall be evaluated by a committee comprised solely of three to five (3-5) NMIMT employees. Offers must address each of the following criteria. Each offer may be awarded points up to the numeric value listed. Points will be awarded in compliance with NMSA 13-1-21 for New Mexico In-State Resident Business and Resident Veteran Business. If offer is a Joint Venture, Proposer shall state in submitted offer the percentage of work that will be performed by Resident Business and / or Resident Veteran Business. Please Note: A Proposer cannot be awarded both a resident preference and a resident veteran business preference. Proposers shall include in their proposal a copy of the certificate issued by State of New Mexico Taxation and Revenue. Offers will be evaluated by NMIMT on the following factors:

4.2 The price portion of the offer shall remain sealed until the evaluation committee has completed its evaluation of the technical portions for all Proposers and has prepared technical scores for each. The evaluation committee will evaluate each Proposer's offer and then establish, by consensus, percentage points for each evaluation criteria. Award will be made to the Proposer(s) who receives the highest total score.

5. TERMS AND CONDITIONS

- 5.1 General
- 5.1.1 NMIMT's Terms and Conditions are an equal and integral part of this RFP.
- 5.1.2 This RFP, addenda, and all attachments will be considered to be part of and incorporated into the resultant contract or purchase order by reference.

- 5.1.3 The Proposer shall include all applicable costs in their proposal, including but not limited to licenses, materials and labor.
- 5.1.4 The freight terms shall be Freight Prepaid unless otherwise agreed to at the time of award. The F.O.B. will be destination unless otherwise agreed to at the time of award.
- 5.1.5 This RFP constitutes the entire agreement between the parties with respect to its subject and shall not be modified, altered or amended in any way except as provided for this RFP. This RFP and the resultant contract will be interpreted and governed by the Laws of the State of New Mexico.
- 5.2 NMIMT reserves the right to select the combination of goods and services that appear best-suited to meet the needs of NMIMT. NMIMT reserves the right to reject any offer outright even if technically superior, if such an offer exceeds NMIMT's available resources.
- 5.3 In evaluating the responses, the Purchasing Services Office reserves the right to accept or reject all or any part of any response, waive minor technicalities and award the contract to the Proposer that best serves the interests of NMIMT.
- 5.4 Expenses for developing offers, pre-proposal and site visits, and for demonstrations, if requested, are entirely the responsibility of the Proposer and shall not be chargeable in any manner to NMIMT.
- 5.5 NMIMT reserves the right to negotiate a change in Proposer's representative if the assigned representative is not supplying NMIMT's needs adequately. The right shall carry forward through the RFP period and the full time during which the service acquired as a result of the Request for Proposal is provided to NMIMT.
- 5.6 If Propoposer's offer is accepted, the offer and appropriate modifications will be incorporated in the contract entered into between NMIMT and Contractor.
- 5.7 The Purchasing Services Office will contract for the proposed goods and / or services from the selected Contractor. Third-Party Subcontractors to the Contractor will be expected to comply with all terms and conditions of the award. During the term of the agreement, no work is to be performed by the Contractor without the express written consent of the Purchasing Service Office. Any work performed without written authorization shall be at the Contractor's expense. Any resulting agreement will be the exclusive statement of understanding between the parties with respect to its subject matter and shall consist of the following, in order of precedence:
 - 1) NMIMT RFP# 2406028E and all addenda
 - 2) Proposer's Offer
- NMIMT shall reserve the right to terminate any contract entered into as a result of the RFP at any time by giving thirty (30) days written notice of its intent to cancel. In the event the Contractor fails to carry out and comply with any of the conditions and agreements to be performed under the specifications, NMIMT shall notify the Contractor, in writing, of such failure or default. In the event the necessary corrective action has not been completed within a ten (10) day period, the Contractor must submit, in writing, why such corrective action has not been performed. NMIMT reserves the right to determine whether or not such noncompliance may be construed as a failure of performance of the contract.
- 5.9 The Proposer must state those standard terms and conditions which the Proposer will expect NMIMT to consider. Any deviation from proposal specifications must be clearly identified by the Proposer. This RFP will prevail in the event of a conflict between the Proposer's offer and the RFP. NMIMT will consider but is not bound by any Proposer's standard terms and conditions. If an impasse occurs, the offer shall be disqualified.
- 5.9.1 Any proposed changes to the terms and conditions attached to this RFP including the additional terms and conditions must be stated in Offeror's proposal in a Section marked "TERMS AND CONDITIONS." Offerors are cautioned that any changes to the terms and conditions that are NOT stated in the RFP response, will not be entertained by NMIMT at a later date. Any provisions in any proposal, quotation, acknowledgment or other forms or contract documents applicable to the services that are inconsistent, or in conflict, with any provisions of this RFP or the resultant contract, will be ineffective and inapplicable.
- 5.9.2 NMIMT reserves the right to reject a proposal on the basis the compromising language which cannot be accepted by NMIMT. Any additional terms and conditions which may be the subject of negotiation will be discussed only between NMIMT and the successful Offeror and shall not be deemed an opportunity to amend the Offeror's proposal.

- 5.10 It shall be each Contractor's responsibility to provide for the safety of workers and public in compliance with the requirements of insurance and public health and safety.
- 5.11 The selected Contractor(s) shall be required to provide insurance certificates to the Purchasing Services Office as part of the resulting contract. Coverage must be maintained in full force for the duration of the contract, or until complete and successful performance of the contract is acknowledged by NMIMT. The following minimum amounts are required:

- 5.12 Each party will be solely responsible for its liability for bodily injury, including death, or damage to property under the common law or statutory law of New Mexico and for only its own attorney fees and costs arising from the act or failure to act of such party or of its regents, directors, members, shareholders, officers, agents and employees pursuant to this Agreement; provided however, the foregoing obligation is a statement of responsibility pursuant to common and statutory law only and does not constitute an agreement to indemnify. The liability and responsibility of New Mexico Institute of Mining and Technology shall be subject to the immunities and limitations of the New Mexico Tort Claims Act, NMSA 1978, Sections 41-4- through 41-4-27, and of any amendments thereto, and shall be construed and applied in accordance with the laws of the State of New Mexico, irrespective of the conflict of law and choice of law principles of New Mexico or any other jurisdiction.
- 5.12.1 The Contractor shall adhere to the Federal Occupational Safety and Health Administration (OSHA) regulations and the State of New Mexico Environmental Improvement Board Occupation Health and Safety Regulations, and Radiation Control Bureau regulations that apply to work performed under this proposal. The Contractor shall defend, indemnify, and hold NMIMT free and harmless against any and all claims, loss, liability and expense resulting from any alleged violation(s) of said regulation(s) including but not limited to, fines or penalties, judgments, court costs, and attorney's fees.
- 5.13 NMIMT is an agency of the State of New Mexico. In accordance with State Statutes, Sections 7-9-13 and 7-9-54, sales of tangible personal property to NMIMT are specifically exempted from New Mexico Gross Receipts Tax. This exemption does not apply to the purchase of services, leases of property, or items purchased for a construction project.
- 5.13.1 All proposal amounts shall EXCLUDE any applicable Gross Receipts Tax. If the resulting contract is taxable, show the amount of the tax as a separate item on the itemized list.
- 5.13.2 Federal Registration #: 85-6000-411 New Mexico Identification #: CRS 01-507116-002
- 5.13.3 A Nontaxable Transaction Certificate (NTTC) can be obtained from NMIMT by sending a request to purchasing@nmt.edu along with company name, address and TIN or NM CRS number.
- 5.13.4 When appropriate, Contractor agrees to certify to the County of Socorro that all applicable Gross Receipts Taxes ("GRT") have been reported and paid under location code 25-025 in the unincorporated areas of Socorro County. Contractor agrees to certify to the City of Socorro that all applicable Gross Receipts Taxes ("GRT") have been reported and paid under location code 25-125 for work performed in the incorporated areas of Socorro.
- 5.14 In accordance with NMSA 13-1-129, Proposers are hereby notified that other governmental entities within the State of New Mexico, or as otherwise allowed by their respective governing directives, may contract for services with the awarded

Contractor. Contractual engagements accomplished under this provision shall be solely between the awarded Contractor and the contracting entity with no obligation by NMIMT.

- The Immigration Reform and Control Act of 1986, Pub L 99-603 (8 USC 1324a) requires employers to verify the eligibility of individuals for employment to preclude the unlawful hiring, or recruiting or referring for a fee, of aliens who are not authorized to work in the United States. This information will be used by employers as a record of their basis for determining eligibility of an employee to work in the United States. The form will be kept by the employer and made available for inspection by authorized officials of the Department of Homeland Security, Department of Labor, and Office of Special Counsel for Immigration-Related Unfair Employment Practices. Submission of the information required is voluntary. However, an individual may not begin employment unless this form is completed, since employers are subject to civil or criminal penalties if they do not comply with the Immigration Reform and Control Act of 1986. - 5.16 Any Contractor and Subcontractor(s) working on a contract(s) entered into subsequent to this RFP shall not discriminate against any employee or applicant for employment, to be employed in the performance of such contract, with respect to its hire, tenure, terms, conditions, or privileges of employment, because of age, color, disability, national origin, race, religion, gender, sexual orientation, or veteran status.
- 5.17 During the term of this agreement, NMIMT reserves the right to contract with the awarded Contractor for additional services as required. Such services shall be performed by mutual consent of the parties and shall be documented by addendum to the contract.
- 5.18 NMIMT reserves the right to audit the Contractor's records associated with this contract at any time during the contract period and for a period of up to three (3) years following the expiration or termination of the agreement. Such audit may be conducted by NMIMT personnel or a third party under contract with NMIMT. NMIMT shall give the Contractor reasonable notice prior to the conduct of any audit and upon receiving the notice from NMIMT the Contractor agrees to fully cooperate with the auditors.
- 5.19 Unless otherwise specifically stated by the Proposer, all equipment, materials, supplies and workmanship furnished or installed is to be free of defects and Proposer shall agree to replace solely at his / her expense any and all defective equipment, parts, etc. within a one (1) year period after the date of acceptance of the items and / or installation unless otherwise agreed to in writing at the time of award. Proposer also warrants the materials, supplies or services furnished to be exactly as specified in the order, free from defects and to be in compliance with any drawings or specifications incorporated herein and with any samples furnished by offeror. All applicable UCC warranties express and implied, are incorporated herein.
- 5.20 The performance of the Contract by NMIMT is contingent upon availability of sufficient funds and sufficient appropriations and authorizations being made by the funding entity(s) for such performance. NMIMT's decision as to whether sufficient funds are available and whether sufficient appropriations and authorizations have been made shall be made in good faith and in its sole discretion, shall be accepted unconditionally by the Contractor, and shall be final. If NMIMT decides that sufficient funds are not available and / or sufficient appropriations and / or authorizations have not been made, it shall notify the Contractor of its decision in writing and may either terminate the Contract or propose modifications to accommodate the insufficient funds and / or appropriations and / or authorizations. If NMIMT proposes modifications, the Contractor shall within thirty (30) days after receiving NMIMT's notice give NMIMT written notice that it has elected either to (i) accept the proposed modifications or (ii) terminate the Contract. If the Contractor fails timely to give such notice, it shall be deemed to have accepted the proposed modifications. In no event shall NMIMT be liable for any financial or other penalty on account of any termination or modification of the Contract as a result of insufficient funds, appropriations or authorizations.

6. DISCUSSIONS WITH PROPOSERS AND AWARD

- The Procurement Code permits, and NMIMT reserve the right to conduct discussions with any or all Proposers, or to make an award of a contract without such discussions based only on evaluation of the written offers. NMIMT likewise reserves the right to designate an Evaluation Committee in evaluating the offers according to the evaluation criteria. NMIMT shall make a written determination showing the basis upon which the award was made and such determination shall be included in the procurement file.
- 6.2 If NMIMT is unable to negotiate a contract with the one selected as most qualified, negotiations will be terminated at the discretion of NMIMT. Negotiations will then be initiated with the next most qualified, or the procurement process will be terminated and new proposals requested.

7. PROCUREMENT CODE

7.1 This award shall be made pursuant to the provisions of the Procurement Code governing procurement of goods and services. Please note that Sections 13-1-199 NMSA impose civil and criminal penalties for violation of the provisions of the Procurement Code. New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities or kickbacks.

8. RESIDENTIAL PREFERENCE

A New Mexico resident business shall be awarded the equivalent of five percent (5%) of the total possible points to be awarded based on the resident business possessing a valid resident business certificate in accordance with Section 13-1-21 of the New Mexico Statutes 1978 Annotated, Chapter 13. If applicable, document the residential preference number in the Offer form and attached the certificate to the response. The preference may not be combined with the Veterans Preference. Procurements involving federal funds are excluded from in state preference laws.

9. VETERANS PREFERENCE

A New Mexico resident veteran contractor, upon providing certification as a resident veteran with their offer, shall be given a preference of ten percent (10%). The preference may not be combined with the residential preference. Procurements involving federal funds are excluded from in state preference laws.

10. TERM

10.1 The terms of this agreement shall be for two years with the option to renew this agreement for up to an additional two year term by mutual consent, not to exceed four (4) years in total.

11. PUBLIC INSPECTION

- General: After award, the register of offers shall be open to public inspection. Each offer, except those portions for which the Proposer has made a written request for confidentiality, shall also be open to public inspection.
- 11.2 Confidential Data: If a citizen of this State requests disclosure of data, for which a Proposer has made a written request for confidentiality, the Chief Procurement Officer shall examine the citizen's request and make a written determination that specifies which portions of the offer should be disclosed. Unless the Proposer protests under Section 13-1-172 NMSA 1978, the offer will be so disclosed. The offer shall be open to public inspection subject to any continuing prohibition on the disclosure of confidential data.

12. LICENSES AND PERMITS

12.1 The Contractor must keep himself informed of, and in adherance to, all laws and ordinances governing any matter related to the services to be performed. The Contractor shall obtain all necessary licenses and permits, and shall be aware of all labor conditions and agreements relating to the work specified in this document and shall make all provisions necessary to avoid any dispute which might arise from those conditions and agreements and shall be responsible for any delays, damages or extra costs caused by such disputes. The Contractor shall be solely engaged in this type of work and service.

13. CONTRACT TERMINATION

- 13.1 NMIMT reserves the right to terminate the contract with ninety (90) days written notice by the Chief Procurement Officer via certified mail to the address listed on the signature page of the RFP if any of the terms of the proposal and subsequent contract are violated.
- 13.1.1 If, through any cause and as determined solely by NMIMT, the Contractor shall fail to fulfill in a timely and proper manner its obligation under this agreement or if the Contractor shall violate or fail to meet any of the covenants, agreements or stipulations of this agreement, NMIMT shall thereupon have the right to terminate this agreement by giving five (5) days written notice to the Contractor of such termination and specifying the effective date of such termination. In such event, all finished or unfinished documents, data and reports prepared by the Contractor under this agreement shall, at the option of NMIMT, become the property of NMIMT, and the Contractor shall be entitled to receive just and equitable compensation for any work satisfactorily

completed hereunder. Notwithstanding the above, the Contractor shall not be relieved of liability to NMIMT for damages sustained by NMIMT by virtue of any breach of this agreement by the Contractor, and NMIMT may withhold any payments to the Contractor for the purposes of set-off until such time as the exact amount of damages due NMIMT from the contract is determined.

13.1.2 NMIMT may terminate the Contract at any time by giving ninety (90) days written notice to the Contractor. If the Contractor is terminated by NMIMT as provided herein, the Contractor will be paid an amount which bears the same ratio to the total compensation as the services actually performed bear to the total services of the Contractor covered by this agreement, less payments of compensations previously made. If this agreement is terminated due to the fault of the Contractor, the "Termination for Cause" clause will apply.

14. GOVERNMENT FLOW-DOWN PROVISIONS

14.1 The resulting order is subcontracted under a U.S. Government Prime Contract, the applicable clauses listed below are incorporated into, and form a part, of the terms and conditions of the resulting order. In the event of any conflict between previously referenced terms and conditions and the Government Flow-Down Provisions, the Government Flow-Down Provisions take precedence. The clauses contained in the following paragraphs of the Federal Acquisition Regulations (FAR) are incorporated herein by reference. For purposes of this Purchase Order, in the following clauses, the term "contract" shall mean "this order", the term "contractor" shall mean "Seller" and the term "Government" and "Contracting Officer" shall mean "New Mexico Institute of Mining and Technology (NMIMT) and the "Chief Procurement Officer" respectively. The following provisions of the FAR apply at the specified order dollar amounts:

15. SCOPE OF WORK

STATEMENT OF WORK

The objective of this Statement of Work is to obtain reliable, efficient, and effective services by applying a concise management and technical approach that will provide the best value and meet the objectives described in this document. The work described is to assist NMT/EMRTC in fulfilling the mission to develop and deliver training courses for the First Responder Training Program – sponsored and funded by DHS/FEMA (Department of Homeland Security / Federal Emergency Management Agency).

NMT/EMRTC is actively broadening its training portfolio, potentially resulting in the development of analogous programs funded independently, both domestically and internationally. When proposing initiatives beyond the First Responder Training Program, consideration of capabilities and pricing is paramount. Kindly specify if there is a preference against involvement in these external programs or pricing agreements as NMT/EMRTC wants to use this pricing information when writing proposals for these new projects.

Prospective bidders may bid on one or more tasks.

For tasks requesting instructor support below, instructors and SMEs are required to have substantial documented experience and specialized technical expertise in course subject matter. Resident course instructors assigned to deliver classroom training concerning explosives must have completed military, state public service, or federal explosives ordnance disposal training (EOD) or be a recognized Explosive Breaching program. Instructor experience and qualifications will be subject to review and approval by NMT/EMRTC. All instructors will be evaluated by NMT/EMRTC and must meet the NMT/EMRTC Instructor Certification Requirements (See Appendix A). Any exceptions will be at the discretion of NMT/EMRTC as well as making the final decision if instructors will continue within the program training functions. Subject Matter Expert (SME) qualifications will be provided for review to NMT/EMRTC and maintained for additional requirements and needs.

Requirements under each task are subject to change based on the needs of the First Responder Program, at the discretion of NMT/EMRTC and/or funding availability. Positions may be terminated at any time based on funding or changes in program requirements/needs. All travel required for this program will be within the U.S. and its Territories and associated costs will meet Federal Travel Policies. Any allowable exceptions must be authorized in writing prior to the travel occurring. When traveling to training sites, no salaries may be charged to the program.

TASK DESCRIPTIONS

TASK 1: Bombing Prevention and Response Instructor Support Services - This task provides Subject Matter Expert (SME) instructor and course SME development support services to NMT/EMRTC for DHS/FEMA-sponsored training courses. These courses are presented in a variety of formats including Resident, Mobile, Conference, and Web-based deliveries as defined below. Examples of bombing prevention and response course subject matter includes, but is not limited to:

- Homemade explosives (HME) recognition
- Bomb threat assessment
- Pre-blast response and post-blast response
- Recognition of bomber ideologies
- Military ordnance recognition
- Medical preparedness and response to blast injuries
- School bombing incident planning and response

Additional courses and subject matter may be added per funding availability.

The period of performance is expected to be from October 1, 2024, to September 30, 2028.

Resident Courses:

Resident courses are conducted on the NMT campus in Socorro, NM, or at a training site managed by NMT/EMRTC. These courses span 3-4 days and feature a blend of lecture instruction and hands-on activities. Key components of these courses include, performance exercises such as live-explosive demonstrations, field assessments, and virtual reality simulations. These

experiences are designed to enhance the learning outcomes for participants by providing practical, real-world applications of the taught concepts.

- Each residential course may require up to 3 part-time SME instructors with instruction hours of:
 - o 24 hours per week (3-day courses), and up to
 - o 40 hours per week (5-day courses).
- Resident course length may change because of 1) the DHS/FEMA course certification and re-certification process which requires courses be revised by NMT/EMRTC's team of SME and curriculum staff or 2) to accommodate logistical needs or limitations of the training site at the discretion of NMT/EMRTC.

NMT/EMRTC estimates 60 courses offered per calendar year but will be determined annually based on funding availability and demand.

Mobile, Customized/Conference, Web-based Courses:

Mobile, Customized/Conference and Web-based courses are conducted at or near a location of the agency requesting training anywhere within the US and its territories. These courses may be tailored to meet specific agency needs and can also be conducted virtually via platforms, such as Zoom, to accommodate remote participants. This adaptability offers specialized training without the logistical needs of traveling to the NMT campus or training facility.

- Each mobile course may require between 1 and 3 part-time SME instructors with instruction hours from 4 to 16 hours.
- Each customized/conference course will require up to 1 part-time SME instructor with instruction hours from 1 to 3 hours.
- Mobile, Customized/Conference, and Web-based course length may change because of 1) the DHS/FEMA course
 certification and re-certification process which requires courses be revised by NMT/EMRTC's team of SME and
 curriculum staff or 2) to accommodate logistical needs or limitations of the training site at the discretion of
 NMT/EMRTC.
- Web-based courses are administered using an LMS system in an independent study format.

NMT/EMRTC estimates 180 courses offered per calendar year but will be determined annually based on funding availability and demand.

For each fiscal year, NMT/EMRTC will identify the number of courses offered and estimated man hour requirements to the contractor when the contract is renewed. Required travel will be within the U.S. and its Territories and associated costs will meet Federal Travel Policies. When travelling to training sites, no salaries may be charged to the program. All courses are subject to change or cancellation as approved by NMT/EMRTC and/or funding availability. Examples of changes may include:

- Course duration changes
- Changes in man hour requirements
- Changes in number of SME instructors required/requested.
- Course cancellations for one instance or indefinitely for inclement weather, participant numbers, funding availability, or any other reason at the discretion of NMT/EMRTC

SME Development Support

SME instructors may be tasked with supporting the development of training courses in accordance with the DSH/FEMA course certification and re-certification process and at the direction of the NMT/EMRTC Curriculum Team. This includes, but is not limited to:

- Conducting preliminary subject research such as collecting data sources and preparing Reports
- Drafting course outlines by developing course learning objectives and lesson topics
- Writing technical course content for the inclusion in official course documentation
- Developing hands-on exercises and activities
- Completing additional tasks as required by the DHS/FEMA course development process.
- NMT/EMRTC will assign/authorize the number of SME's required to develop or create new course or existing courses in the re-certification process. Written confirmation from the Training Program Manager must be obtained authorizing who is assigned and the number of SMEs assigned to each curriculum project.

1.1 The subtasks include:

1.1.1 Contractor will be responsible for recruiting, identifying, hiring, and supervising instructors that meet the required experience level. Instructors must have substantial experience and specialized technical expertise in subject matter areas of course assignment.

- 1.1.2 Ensuring all course content files, such as instructor and participant guides being used are current.
- 1.1.3 Instructors' training and certifications must meet or exceed the NMT/EMRTC Instructor Certification Program Requirements (See Appendix A).
- 1.1.4 Instructor experience and qualifications will be subject to review and approval by NMT/EMRTC.
- 1.1.5 Annual requirements: All instructors will be evaluated and reviewed by NMT/EMRTC annually according to the NMT/EMRTC Instructor Certification Program Requirements. Additionally, instructors will be required to attend, in person, instructor development training hosted by NMT/EMRTC at least once every two years.
- 1.1.6 NMT/EMRTC reserves the right to approve all instructors prior to hiring and when hired, whether he/or she will continue to support the program.
- 1.1.7 Contractor is responsible for briefing NMT/EMRTC on any and all deficiencies or issues identified in classroom deliveries.
- 1.1.8 Contractor is responsible for establishing a Point of Contact (POC) who will schedule instructors as needed.
- 1.1.9 Contractor is responsible for instructor disciplinary actions and termination.
- 1.1.10 Contractor, via instructors, will be responsible to perform training functions in the classroom, field presentations, and to aid NMT appointed representative(s) with other functions as required to develop and deliver courses.
- 1.1.11 Contractor and instructors may be required to support the National Bomb Commanders Training and Symposium hosted by NMT/EMRTC and other special events. Once these events are identified and finalized the appropriate contractor will be notified by NMT/EMRTC.
- 1.1.12 Prior to the start of courses assigned the contractor will be responsible for providing a six-month schedule with appointed instructors. For every six-month period thereafter, the same process will apply. SMEs must be appointed and approved in writing prior to curriculum development beginning.
- 1.1.13 For Mobile and Conference course deliveries, contractor is responsible for managing all aspects of the training functions in the classroom i.e., provide presentations, manage and utilize instructional equipment to present classes, and support and manage class participants at host facilities.
- 1.1.14 Resident, Mobile and Conference course outreach and public relations will be documented and provided by NMT/EMRTC personnel. These efforts could include, but are not limited to, email, phone calls, conferences presentations, and correspondence with emergency response/emergency management agencies, state training coordinators, and first responder associations and organizations. Contractors are expected to support these outreach efforts when teaching for NMT/EMRTC.
- 1.1.15 Instructors may be required to use and/or assist participants with a variety of learning devices such as tablets/mobile devices, or VR equipment.

TASK 2: Tactical Bombing Response Instructor Support Services - This task provides Subject Matter Expert (SME) instructor and course SME development support services to NMT/EMRTC for DHS/FEMA sponsored training courses. These courses are presented in a variety of formats including Resident, Mobile, Conference, and Web-based deliveries as defined below. Examples of tactical bombing response course subject matter includes, but is not limited to:

- Identification of active suicide bombers
- Tactical response to an active suicide bomber
- Mitigation of suicide bomber effects/hazards
- Prioritization of life-saving tactics at an active suicide bomber incident

Additional courses and subject matter may be added per funding availability. Period of performance is expected to be from October 1, 2024, to September 30, 2028.

Resident Courses:

Resident courses are conducted on the NMT campus in Socorro, NM, or at a training site managed by NMT. These courses span 3-5 days and feature a blend of lecture instruction and hands-on activities. Key components of these courses include, performance exercises such as live-explosive demonstrations, field assessments, and virtual reality simulations. These experiences are designed to enhance the learning outcomes for participants by providing practical, real-world applications of the taught concepts.

- Each residential course may require up to 3 part-time SME instructors with instruction hours of:
 - o 24 hours per week (3-day courses), and up to
 - 40 hours per week (5-day courses).
- Resident course length may change because of 1) the DHS/FEMA course certification and re-certification process
 which requires courses be revised by NMT/EMRTC's team of SME and curriculum staff or 2) to accommodate
 logistical needs or limitations of the training site at the discretion of NMT/EMRTC.

NMT/EMRTC estimates 12 courses offered per calendar year but will be determined annually based on funding availability and demand.

Mobile, Customized/Conference, Web-based Courses:

Mobile, Customized/Conference, and Web-based courses are conducted at or near a location of the agency requesting training anywhere within the US and its territories. These courses may be tailored to meet specific agency needs and can also be conducted virtually via platforms, such as Zoom, to accommodate remote participants. This adaptability offers specialized training without the logistical needs of traveling to the NMT campus or training facility.

- Each mobile course may require between 1 and 3 part-time SME instructors with instruction hours from 4 to 16 hours.
- Each customized/conference course will require up to 1 part-time SME instructor with instruction hours from 1 to 3 hours.
- Mobile, Customized/Conference, and Web-based course length may change because of 1) the DHS/FEMA course
 certification and re-certification process which requires courses be revised by NMT/EMRTC's team of SME and
 curriculum staff or 2) to accommodate logistical needs or limitations of the training site at the discretion of
 NMT/EMRTC.
- Web-based courses are administered using an LMS system in an independent study format.

NMT/EMRTC estimates 20 courses offered per calendar year but will be determined annually based on funding availability and demand.

For each fiscal year, NMT/EMRTC will identify the number of courses offered and estimated man hour requirements to the contractor when the contract is renewed. Required travel will be within the U.S. and its Territories and associated costs will meet Federal Travel Policies. When travelling to training sites, no salaries may be charged to the program. All courses are subject to change or cancellation as approved by NMT/EMRTC and/or funding availability. Examples of changes may include:

- Course duration changes
- Changes in man hour requirements
- Changes in number of SME instructors required.
- Course cancellations for one instance or indefinitely for inclement weather, participant numbers, funding availability, or any other reason at the discretion of NMT/EMRTC

SME Development Support

SME instructors may be tasked with supporting the development of training courses in accordance with the DSH/FEMA course certification and re-certification process and at the direction of the NMT/EMRTC Curriculum Team. This includes, but is not limited to:

- Conducting preliminary subject research such as collecting data sources and preparing reports
- Drafting course outlines by developing course learning objectives and lesson topics
- Writing technical course content for the inclusion in official course documentation
- Developing hands-on exercises and activities
- Completing additional tasks as required by the DHS/FEMA course development process.
- NMT/EMRTC will assign/authorize the number of SME's required to develop or create new courses or existing courses in the re-certification process. Written confirmation from the Training Program Manager must be obtained authorizing what SMEs are assigned and the number of SMEs assigned to each curriculum project.

2.1 The subtasks include:

- 2.1.1 Contractor will be responsible for recruiting, identifying, hiring, and supervising instructors that meet the required experience level. Instructors must have substantial experience and specialized technical expertise in subject matter areas of course assignment.
- 2.1.2 Ensuring all course content files, such as instructor and participant guides, are current.
- 2.1.3 Instructors' training and certifications must meet or exceed the NMT/EMRTC Instructor Certification Program Requirements (See Appendix A).
- 2.1.4 Instructor experience and qualifications will be subject to review and approval by NMT/EMRTC.
- 2.1.5 Annual requirements: All instructors will be evaluated and reviewed by NMT/EMRTC annually according to the NMT/EMRTC Instructor Certification Program Requirements. Additionally, instructors will be required to attend instructor development training hosted by NMT/EMRTC at least once every two years.
- 2.1.6 NMT/EMRTC reserves the right to approve all instructors prior to hiring and when hired, whether he/or she will continue to support the program.
- 2.1.7 Contractor is responsible for briefing NMT/EMRTC on all deficiencies or issues identified in classroom deliveries.
- 2.1.8 Contractor is responsible for establishing a Point of Contact (POC) who will schedule instructors as needed.
- 2.1.9 Contractor is responsible for instructor disciplinary actions and termination.
- 2.1.10 Contractor, via instructors, will be responsible to perform training functions in the classroom, field presentations, and to aid NMT appointed representative(s) with other functions as required to develop and deliver courses.
- 2.1.11 Contractor and instructors may be required to support the National Bomb Commanders Training and Symposium hosted by NMT/EMRTC and other special events. Once these events are identified and finalized the appropriate contractor will be notified by NMT/EMRTC.
- 2.1.12 Prior to the start of courses assigned the contractor will be responsible for providing a six-month schedule with appointed instructors. For every six-month period thereafter, the same process will apply. SMEs must be appointed and approved prior to curriculum development.
- 2.1.13 For Mobile and Conference course deliveries, contractor is responsible for managing all aspects of the training functions in the classroom i.e., provide presentations, manage and utilize instructional equipment to present classes, and support and manage class participants at host facilities.
- 2.1.14 Resident, Mobile and Conference course outreach and public relations will be documented and provided by NMT/EMRTC personnel. These efforts could include, but are not limited to, email, phone calls, conferences presentations, and correspondence with emergency response/emergency management agencies, state training coordinators, and first responder associations and organizations.
- Contractors are expected to support these outreach efforts when teaching for NMT/EMRTC.
- 2.1.15 Instructors may be required to use and/or assist participants with a variety of learning devices such as tablets/mobile devices, or VR equipment.

TASK 3: Training Site Support

This task supports course delivery at the NMT/PRTC training site (Playas Research and Training Center). Requirements are determined by NMT/EMRTC based on course needs.

• Staffing: Contractor will provide one representative for activities 1 and 2 (Sunday through Friday, up to 40 hours) and 2-3 representatives for activity 3 (Sunday through Friday, up to 40 hours). These are part-time positions, with training occurring, typically, one week per month.

Services include:

- 1. Training Setup/Takedown: Assist with classroom/laboratory setup and teardown.
- 2. Daily Housekeeping: Maintain classrooms and prepare/stock the snack room.
- 3. Food Management: Provide and manage meals and snacks within federal per diem rates, including onsite cooking and helpers.

Annual Planning: NMT/EMRTC will provide course numbers and estimated man-hour requirements annually. Courses may change or be canceled, affecting site support needs. Examples include changes in course duration, instructor/participant numbers, man-hour requirements, or cancellations due to various reasons.

The period of performance is expected to be from October 1, 2024, to September 30, 2028.

TASK 4: Training Course Scheduler

This task supports the First Responder Program at NMT/EMRTC by efficiently scheduling all offered courses. The scheduler must have significant experience within the first responder community and be adept at communicating with State, Local, Federal, and Tribal agencies to organize NMT/EMRTC FEMA-approved courses.

- Location: Based in Socorro, NM, unless otherwise approved.
- Responsibilities: Work under NMT/EMRTC management to establish priorities, coordinate outreach efforts and personnel.
- Travel: May be required as needed and approved.
- Hours: Not to exceed 40 hours per week.

The period of performance will be from October 1, 2024, through September 30, 2028.

4.1 The subtasks include:

- 4.1.1 Communication with SAA (State Administrative Agency) Training Coordinators for all NMT/EMRTC Residential, Mobile. Conference and Web courses
- 4.1.2 Coordinate outreach team and efforts for participant recruitment.
- 4.1.3 Ensure the training schedule has the correct number of participants for each iteration.
- 4.1.4 Ensure Residential courses are scheduled and filled with the required number of participants.
- 4.1.5 Provide information to participants on course and travel requirements.
- 4.1.6 Provide reports on the scheduling process and statistics to NMT/EMRTC
- 4.1.7 Maintain an ongoing liaison with SAA Training Coordinators

Task 5: Curriculum Coordinator and Development

This task provides Curriculum Coordination and Instructional Systems Design expertise to develop training curricula and corresponding course materials. Curricula and associated course materials must be developed following standards and requirements from DHS/FEMA and the National Training and Education Division (NTED) (or corresponding authority/stakeholder). As such, curricula must meet or exceed established and evolving standards placed on NMT/EMRTC by DHS/FEMA and/or other agency of authority or stakeholder. Additionally, this task will support the implementation of learning technologies and systems utilized to facilitate course deliveries and/or their administration under the direction of NMT/EMRTC.

NMT/EMRTC currently offers multiple courses with additional ones undergoing development; new courses may be added or removed at the discretion of NMT/EMRTC and per funding availability. Examples of existing courses include, but are not limited to:

- Response to Bombing Incidents, Course Series
- Prevention of Bombing Incidents, Course Series

- Initial Law Enforcement Response to Suicide Bombing Attacks, Course Series
- Tactical Response to Suicide Bombing Incidents, Course Series
- Drone Assessment Response Tactics, Course Series

The period of performance is expected to be from October 1, 2024, to September 30, 2028.

5.1 The subtasks include:

5.1.1 Providing, at a minimum, staff who will operate within the NMT/EMRTC Curriculum Team who can support the outlined tasks at the direction of NMT/EMRTC.

5.1.2 Coordinate the development and sustainment of curricula and course material throughout the DHS/FEMA (or corresponding authority/stakeholder) development process from inception to the continued sustainment or as directed by NMT/EMRTC.

Tasks include, but are not limited to:

- Assigning, and coordinating Subject Matter Expert (SME) development support staff and guiding processes to
 ensure all requirements are met.
- Overseeing course certification and re-certification schedule, including but not limited to creating timelines or development schedules.
- Supporting instructor training and evaluation according to the NMT/EMRTC Instructor Certification Program Requirements (See Appendix A).
- Coordinate development with DHS/FEMA NTED Program Manager as necessary or as required by existing or evolving standards.
- 5.1.3 Develop course material utilizing varying learning technologies and software as appropriate for multiple delivery modalities including, but not limited to, instructor-led training, remote or virtual training, and online training.
- 5.1.4 Development of course material by DHS Trusted Tester(s) that meets or exceeds
 Section 508 of the Rehabilitation Act which includes, but is not limited to, developing captions, audio descriptions, PDF
 tags structures, meeting WCAG requirements, or alternate delivery methods to ensure users with accessibility needs can
 access material using assistive technologies.
- 5.1.5 Provide information to participants on course and travel requirements.
 - DHS/FEMA NTED courses of all modalities and the entirety of their components must be found 508 compliant by DHS/FEMA independent reviewers.
- 5.1.6 Conduct periodic evaluations of curricula to ensure consistent quality and that DHS/FEMA (or corresponding authority/stakeholder) standards are met and maintained by observing deliveries and/or analyzing data to recommend and manage the implementation of improvements to curricula and related course delivery components where/as necessary in coordination with NMT/EMRTC.
