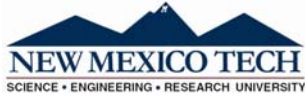

## **Assistant Professor of Civil and Environmental Engineering**

**Position Description:** The Department of Civil and Environmental Engineering invites applications for a full-time, tenure-track assistant professor position in the area of structural engineering. Applicants must have a demonstrated interest in engineering education and an ability to teach a variety of civil engineering courses, including courses in structural engineering, construction materials, design of steel and concrete structures, and the use of finite elements in the design of structures. Applicants will be expected to develop an externally funded research program and to participate in other scholarly activities. Professional engineering (P.E.) registration or significant progress towards licensure (FE) is desired. The applicant must possess a bachelor's degree in engineering and a doctoral degree in civil engineering, or a closely related field. It is preferred that applicants possess consulting or industrial experience, and experience with contemporary structural engineering software packages. Demonstration of proficiency in written and spoken English language is required. Opportunities exist for research collaboration with several campus departments, research centers and with nearby National laboratories. U.S. Citizenship may be required to collaborate with certain research entities. The successful candidate will start at New Mexico Tech in August of 2020. Applications should include a cover letter summarizing education and experience, a complete vita, a statement of teaching and research interests, and a list of at least three professional references.
