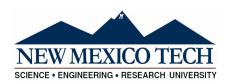

The Explosive Processing Manufacturing Manager will oversee the explosive manufacturing and processing sites and programs at EMRTC. Specific duties include: maintaining equipment, supervising personnel, developing procedures, writing SOPs, interacting with tenants and customers to produce articles as specified. Manage the workflow for a production project, ensure efficiency during the process, and oversee the quality assurance of produced materials. They will contribute to programming, tooling and fixturing specifications as part of the process development activities. Experience in one or more fields are required: 1) explosive processing, 2) melt-casting, 3) polymer-casting, 4) die design 5) machining. Assisting with proposal preparations and cost estimating. Remote machining experience desired.
