

JOB SUMMARY:

Responsible for maintaining the programs and data structures of enterprise-wide computer applications and related subsystems. Responsible for evaluating, designing, and implementing solutions to complex information technology problems, and for the integration of discrete software systems. Responsible for the development of new techniques and procedures to improve overall system functionality and performance. Works with users, coworkers and vendors to resolve problems quickly, achieving deadlines while maintaining high standards of accuracy. Some evening, weekend and on-call duties are expected to perform after-hours upgrades and maintenance. Performs other job-related duties as assigned. NMT has a remote/hybrid work policy and this position may qualify.

Direct experience programming Oracle structures (e.g. functions, procedures, views and packages), or SQL Server experience in an enterprise environment. Experience in programming high-level programming languages in an enterprise environment. Experience in the development and implementation of technical solutions in an enterprise environment. Experience in writing reports with at least one high-level report-writing language package. Experience in web development languages and/or framework (e.g. PHP, Python, Ajax, Javascript). Demonstrated ability to interact with end-users to detect problems and arrive at solutions. Demonstrated ability to interface different software products together. Experience with Ellucian/Banner ERP systems and/or experience with higher education administrative systems. Must be a US Citizen and be able to pass a criminal background check/CJIS certification.
