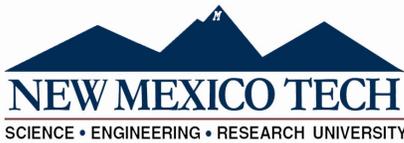

JOB SUMMARY:

This position is the lead Cybersecurity Maturity Model Certification (CMMC) and Information Technology (IT) person for EMRTC. The position will be responsible for implementing procedures and assisting with establishing policies leading towards CMMC verification depending on the levels required. The position will lead EMRTC and NMT's CMMC validation process and will ensure that EMRTC meets all CMMC requirements up to level 5 in the future. This position will also be responsible for managing EMRTC's Information Technology Department, including reviewing and approving budgets, financial status, staff, equipment, software, purchases, and operations. This position will also coordinate with other NMT departments needing CMMC and will assist with electronic processes, equipment purchases, policies, information, and data as needed in support of the other departments. This position will report to the EMRTC Director and support other EMRTC operations as needed.
