

JOB SUMMARY:

This is a trainee level to mid-level technical specialist position in a research compliance division and supports one or more functional areas of industrial security and export control management programs for the University under general supervision. Assesses security threats to the University and implements appropriate strategies and counter measures. Reviews and analyzes data and devises risk minimization programs. Participates in a campus-wide regulatory compliance program. May serve as the University's representative to community and government agencies for industrial security matters. Creates, develops and delivers resources for security programs. May serve as a Facility Security Officer (FSO), assistant FSO, Contractor Special Security Officer (CSSO) or assistant CSSO. Located at Playas Research & Training Center in Playas, NM.

JOB FUNCTIONS:

Coordinates one or more facets of the University's Industrial Security, Export Control and other related security programs.	30%
Monitors security threats, gathers information and reports suspicious activities; Conducts risk mitigation and plans appropriate strategies and countermeasures.	15%
Represents the organization to regents/faculty/staff/students and may serve as a security liaison between the university and governmental agencies and investigative organizations in specific Industrial Security and/or Export Control matters.	10%
Recommends, participates in the development of, and establishes university policy and procedures; monitors and evaluates program effectiveness; implements changes required for improvements.	5%
Serves as an advisor, as needed, on security management issues related to the design and construction of physical facilities.	5%
Manages sensitive security records, databases and reporting; performs and coordinates security inspections, investigations and surveys.	20%
May oversee specific industrial security functions of remote facilities.	5%
Participates in the development of strategies and programs for departmental use.	5%
Performs miscellaneous job-related duties as assigned.	5%

REQUIRED QUALIFICATIONS:

Bachelor's Degree in Any area of study. Four (4) years of relevant experience may be substituted for a Bachelor's degree. Preference given to degree-holding candidates. Proficiency is the use of MS Office. US Citizenship (required for Security Clearance eligibility). A valid NM Driver's License.
