

In response to an appeal submitted by SWE on behalf of SWE, Tri-Beta, Cybersecurity, AISES, and LoL Club(s) I have written the following response:

I would like to be clear in my position that I have no favorites or prejudices with any clubs or organizations currently. In the following I will present conversations held between myself and any Officer, Advisor, or other participant. I believe to have upheld the Constitution to best of my ability with the knowledge and training I received and all experience I have gained in this office.

- 1.) In regards to SWE I met with Bobbi Taylor in my office on Monday, September 23rd. She sent me an email summarizing the discussion and I also emailed Michelle individually asking about individual members receiving funding in the same day. While I did not receive a response from Michelle I managed to meet in my office briefly with her and Chief Justice Sheerin to discuss any loophole or possibility for allowing clubs with late paperwork to receive status on Tuesday, September 24th. I emailed Bobbi with the response two days after our meeting (Wednesday September 25th, and heard nothing more after that. Attached below are emails sent to Bobbi and Michelle.
- 2.) In regards to AISES I was asked by Quincy in office if someone who was *not* Peyton Sage was an officer of AISES. When I checked the club packets there wasn't one submitted in my office or in Quincy's. I still have not received one from AISES. We never actually met but Chief Justice Sheerin was in my office and met Peyton informing her that it was a hard deadline. Again, I didn't receive any more contact from them until now. Attached below is correspondence between me and Peyton.
- 3.) In regards to League of Legends Club, I was approached by Roy Geiger in office after the due date asking me if I had received the packet. I hadn't at the time and he said he would get it to me. Almost two weeks later at dinner Roy and I ate together where he asked me if I had gotten the packet. I told him I hadn't and I wouldn't be able to give him club status unless he could show me that there had been an attempt to submit the club packet before the due date. I still have not received a packet or had any more communication from this club. Attached are results from searches in my email from Roy's student account and from the League of Legends account.
- 4.) In regards to Cybersecurity, I received their packet on Monday, September 16th, after finding it submitted to Michelle's office. I received an email from Brendan on the same day and informed him that I wouldn't be able to take the packet but that they could fill

one out in the Spring and be a chartered SGA organization then. Attached below is my email from Brendan and my response.

- 5.) In regards to Tri-Beta, I sent them an email on Wednesday, September 25th after receiving their packet on my door that day. I got a response from their faculty advisor, not their co-president who was also on the email. I emailed Michelle and Quincy—who confirmed he at least received the email—about how individual students could get funding. After not getting a response for two days the question being sent on October 1st and me waiting until October 3rd, I responded to Mr. Duvall explaining a process which students could use to still receive funding. I never got another response from Mr. Duvall or from Heather Curtsinger who is listed as a “Co-Presidente” and who was on the first email.

After the committees were selected I gave this information to Sam Fischer who was at the time the Chair of the Club Advisory Committee. At this time Socorro Search and Rescue (SSAR) was also denied club status due to their packet being late for no other reason than there hadn't been a reminder about the deadline. His report noted that SSAR should receive status because without it there was a risk that they would lose access to school facilities that stored their equipment not owned or stored by students. It was directly after that meeting that Mr. Fischer moved to become the AFO under Quincy. Senator Mario Marquez was named the new committee head.

I have attached all emails between myself and any club or organization in this appeal. According to Sections 4.12.1 through 4.12.6 of the Constitution I have fulfilled these practices and laws fully, honestly, and to the best of my ability. It is my opinion that these clubs should remain in their status until the Spring 2020 semester when they can complete their packets fully and on time. On my side I will try to provide more of the same information more frequently. I again wish to express that I do not have any preferences or grudges towards any clubs or organizations at this school. Beyond academics our clubs are the heartbeat of Tech something I advocated at every Orientation this year when speaking to incoming freshmen. I am responsible for upholding the Constitution and I believe that I have done that fairly and fully in these cases. I am sure that the Club Advisory Committee under the leadership of Senator Marquez is willing to hear these cases individually as well if need be. It is my pleasure to serve in the capacity of Vice President. I now only ask that when evaluating this appeal the Senate recognizes what is written and what has been practiced and to find where the two diverge.

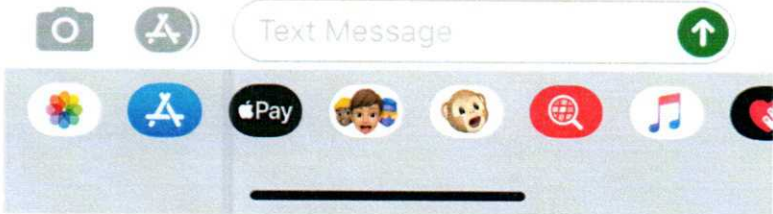

Hello Nikki/Dallin,

We talked earlier today so this email just summarizes that conversation. I am speaking on behalf of the Society of Women Engineers club.

Essentially, the problem is I submitted my club packet in late. I am not trying to justify why it was late because the SGA gave us a two week period to get this all done. Being new to an officer position (president at that) with a club that only had 3 returning members has posed its own challenges. My main focus since school started up has been on outreach and trying to recruit freshman to join SWE. What little guidelines there were for my position were scattered and incoherent. I would not say I have been lax with SWE, just that my focus has been on rebuilding the club.

I understand there aren't any by-laws that specify what to do if a club turns in a packet late. I am hoping that maybe some could be made, such as creating a penalty for those turned in late, but still allowing them to be turned in. I understand I am probably not the only club to miss the deadline, so I feel others could benefit from this.

Since SWE only does one conference a year, and it's in the fall, I would hate for my negligence to impact the freshman who I have already recruited. There would not be a spring semester equivalent to the annual SWE conference. On top of that, we are hoping to still host events to help publicize SWE and recruit members. I mentioned that I would be willing to do more volunteer hours for the SGA as a consequence for turning in the packet late.
